Entries close at 11:00 PM Wednesday October 29, 2025; a wait list will be started when the numerical limit has been reached. If reached before Wednesday, 2025 (at Trial Secretary office) after which entries cannot be accepted, cancelled, or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules. A Wait List to be established before closing date. AKC RECORDING FEE of \$0.50 & an AKC Event Service Fee of \$3.50 is required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tacking Test. If a dog is entered in more than once class in one of the events, the AKC Recording Fee and Service Fee is to be collected on the first entry only. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). An AKC Recording Fee of \$3.50 will be required for each entry in any Licensed or Member Club Rally Trial. If a dog is entered in more than one class in a Rally event, the AKC Recording Fee is to be collected on each of the entries of that dog. (AKC Rally Regulations, Chapter 1, Section 3). All Recording Fees are paid to the American Kennel Club. RETURNED CHECKS do not constitute a valid entry fee. DKC will add a \$45.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis. ENTRIES RECEIVED WITHOUT FEES will not be accepted. Telegraph and unsigned entries cannot be accepted. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Trial Secretary will make every effort to decipher illegible handwriting but is not responsible for errors due to illegible writing. ENTRY FEES shall not be refunded if a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made after closing date. BITCHES IN SEASON. Since bitches in season are not permitted to compete in Obedience Trials, all but \$10.00 of the entry fee for bitches unable to compete for that reason, will be refunded. To be eligible for such refund the Trial Secretary must be notified in writing ½ hour or earlier prior to start of first class of the trial together with a veterinarian's certificate on their letterhead confirming the fact that the bitch is in season.

CONSULT JUDGING PROGRAM FOR TIME OF JUDGING

Judges will not wait for any dog holding up a class. Owners/agents are responsible for having their dogs in the judging rings when classes are called. The Show-giving Club and the Secretary have no obligation or responsibility for providing services through a public address system or stewards or runners for the purpose of calling/locating dogs. Dogs may arrive any time prior to their scheduled time of judging. Dogs not needed for further judging will be excused.

THE SHOW COMMITTEE will use care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability, in the event of an accident or misfortune to either dogs or exhibitors participating in the show. THE OBEDIENCE TRIAL AND RALLY TRIAL will be open from 8:00 A.M. to ½ hour after trial ends.

The Duluth Kennel Club, Inc., does not agree to arbitrate claims as set forth on the Official AKC Entry Form for these events.

DECLINATION OF ENTRIES/REMOVAL OF DOG: The trial committee may refuse to admit or may remove any dog on account of disease, viciousness, or other causes, and no one shall have any claim or recourse against the trial-giving club or any official thereof. All dogs must be on leash or confined to a crate except when being judged.

Management is NOT responsible for the loss of, damage to, or death of any dog exhibited, or for the possessions of any participant, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.

 Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas
 (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles),
